BS EN 1176 / 1177 Playground Safety Standards Roadshow 2017/2018 Revisions

The Play Inspection Company, in association with HAGS, are running roadshow events throughout 2018 focusing mainly on the updated EN Standards for Children's Playground Equipment and surfacing. Andy, Jon & Keith will discuss the changes to BS EN 1176 / 1177 and the impact that this could have on your business / organisation, as well as providing an insight into other standards that are applicable to other types of play spaces (such as Outdoor Fitness Equipment / Wheeled Sports / Multi Use Games Areas / Parkour) and will also cover some of the most newsworthy topics in the industry today.
